## Membership Report



## Why Should I become a Voluntarily Registered (VR) Provider?

#### What are the benefits of being voluntarily registered?

- VR providers can participate in the USDA food program and receive reimbursements for applicable meals served to
- VR providers can participate in the "subsidy" program and receive payments to care for children whose parents are eligible for assistance with child care:
- VR certificates are issued for a two-year period unlike the child care subsidy approval process, which only lasts as long as "subsidy" children are enrolled in an unregulated home:
- VR homes can have a mixed enrollment of private-pay children and children who receive subsidies;
- VR homes are listed on the Virginia Department of Social Services (VDSS) website used by parents to locate child care options;
- VR providers can assure parents that they are in compliance with basic health and safety requirements, that the home has been inspected, and that applicable background checks have been completed;
- VR providers can participate in trainings offered through VDSS, contract agencies, local departments of social services, USDA sponsoring agencies; receive technical assistance; and may even elect to participate in on-site technical assistance from Infant and Toddler Specialists when the home serves infants and toddlers; and
- VR providers are still operating an independent business, but VDSS will help you stay informed about changes in child care that affect **YOU**, (e.g. immunization requirements, new federal guidelines for cribs, etc.).

Licensed Family Child Care Providers And Voluntarily Registered Providers: Join USDA Child & Adult Care Food Program (CACFP)!

Receive reimbursements for healthy, nutritious meals and snacks served to the children in your care under the age of 13; this may include provider's own children.

Providers are reimbursed monthly by check or direct deposit.

Attend trainings and receive technical assistance on quality care and nutrition. Providers use a free, web-based claim submission and child enrollment system.

Promote your child care business by engaging in networking opportunities, offering healthy meals, and joining the national effort to reduce childhood obesity.

> CACFP participation is a NAFCC criterion for national accreditation.

#### Tips on Cutting Expenses

There are only three ways of making more money doing family child care:

1) Take care of more children

2) Raise your rates

3) Reduce your expenses

Of the three, reducing your expenses is probably the easiest to accomplish. Here are some sugestions on how to do this:

When you shop, you may be able to reduce your spending if you follow this advice: shop alone, use a shopping list, bring a limited amount of cash with you, set a limit on how much time you will spend in the store, eat just before you shop for food, and don't shop if you are in a bad mood (because some people will try to improve a bad mood by spending more money).

Reduce the number of times you eat out with your family. When you do, don't buy drinks at the restaurant. Have a drink at home when you return.

At least twice a year go through your home to determine what items can be sold at a garage sale or given to a charity.

Do you have seldom-worn jewelry that could be sold to pay off a debt?

Request an energy audit of your home to get ideas on how to improve energy efficiency.

Drive your car until you own it, and then keep it as long as you can after that.

Before buying anything, ask yourself whether the item is a want or a need.

Tired of getting all those offers in the mail for credit cards? To remove your name from prescreened credit or insurance offer mailing lists, call 1-888-567-8688. They will contact major credit card bureaus and you will no longer get direct marketing offers. There is no fee for this service. You can also fill out an on-line form to opt out.

Spend less each year than you make.

Pay off all credit card debt.

Don't be afraid to start saving small amounts. They add up. The act of saving begets the habit of saving. Purchase insurance to protect against major catastrophes: life, disability income, health, long term care, business liability. Teach your children to save.

#### Home made paint

1 cup water,1 cup liquid dish soap,food coloring

## Tips for Licensed Providers

I have noticed over the last several years providers are receiving fewer violations when they have their inspections. This is a very good thing! Since we are all human, we know we can't be perfect all the time. Paperwork still seems to be the #1 violation most of us receive. The following items are what I found online:

Remember to update your annual emergency response plan, sign and date your plan.


Have parents sign the bottom of page 1 of the Child's Record form annually.

If you have swings with "5" hooks, make sure they are tightly closed and have flexible seats.

Maintain paperwork for provider, assistants, and household members – including TB tests every 2 years, CPR & 1<sup>st</sup> aid every 2 years, child protective services every 3 years, and criminal history every 3 years.
